Pure Brodifacoum (No. CAS 56073-10-0)
Denatonium Benzoate (No. CAS 3734-33-6)
Palatable substances and co-formulants

CHARACTERISTICS

BRORAT BLOCK is a ready-for-use rodenticide bait with at its base the anticoagulant active substance known as Brodifacoum, which is effective against House Mouse (*Mus musculus*), Grey Rat (*Rattus norvegicus*), and Black Rat (*Rattus rattus*) even after a single ingestion. Its formulation consists of a "waxed block" that is palatable for the rodents' species mentioned above. The product does arouse neither alarm nor suspicion among the other members of the rodents' population. **BRORAT BLOCK** contains a bitter substance aimed at preventing children from swallowing it accidentally. **BRORAT BLOCK** can be used inside and around industrial buildings (including storerooms, warehouses, and ship holds), rural and civil buildings, houses, basements, garages, storerooms, gardens, and outbuildings.

DOSES AND MODES OF USE

The product is ready for use and must be employed in accordance with the doses below. The rodenticide bait must be inserted in a tampering-proof duly marked bait container, protected against atmospheric agents, the ingestion by non-target species and the dispersion into the environment.

Bait containers must be placed in the immediate proximity of places where the rodents' activity has been already verified (for example walkways, nests, entrance enclosure of livestock, openings, burrows, etc.). Where possible, secure bait containers to the ground or to other structures. Bait containers must be clearly labelled by reporting that they contain rodenticides and must not be removed or opened.

Recommended doses are:

House Mouse: 40 g per container, equal to 2 baits in ready-for-use waxed blocks of 20 grams each.

Grey Rat: 60-100 g per container, equal to 3-5 baits in ready-for-use waxed blocks of 20 grams each.

Black Rat: 60-100 g per container, equal to 3-5 baits in ready-for-use waxed blocks of 20 grams each.

Should more containers be necessary, place them at a distance from another of about 5-10 metres and in any case not less than 5 metres.

The frequency of visits to the treated area should be at the operator's discretion, in light of the investigation carried out at the beginning of the treatment. If bait consumption is low compared with the evident dimension of the infestation, consider to re-position bait points in other places and to change the type of bait formulation.

At the end of the treatment period remove the remaining baits or bait containers. Do not open the bags containing the bait.
