Pure Permethringr. 0.3Pure Tetramethringr. 0.3Pure Piperonyl Butoxidegr. 1Formulants and waterq.s. to gr. 100

FEATURES

RETHRIN is a ready for use insecticide in water microemulsion which acts by contact and ingestion with a strong destroyed action and medium persistence. The formulation is effective against all insects in cold blood. **RETHRIN** contains no gas propellants.

RETHRIN is indicated for use in homes and civilians, such as hospitals, schools, food manufacturers, hotels, restaurants, stores. Use only for mosquitoes is also allowed for treatment in green areas, bushes and hedges, lawns. **RETHRIN** is effective against a wide range of flying insects including flies (*Musca domestica*), mosquito (*Aedes albopictus* and *Culex pipiens*), wasps (*Vespula spp*), horseflies, sandflies, including chironomids and crawling cockroaches (*Blatta orientalis*), ants (*Lasius spp*.), bedbugs, cockroaches, silverfish, earwigs.

DOSES AND USE

RETHRIN not stain and is atomized as it is known where the presence of insects, along the door frames, floors, around the animal shelters, on the walls, in corners, crevices, and under mosquito nets sinks.
