## READY-FOR-USE BROMADIOLONE-BASED PELLETTED RODENTICIDE BAIT - FOR PROFESSIONAL USE -

### COMPOSITION

Pure Bromadiolone (No. CAS 28772-56-7)	gr. 0,005
Denatonium Benzoate (No. CAS 3734-33-6)	gr. 0,001
Palatable substances and co-formulants	quantum satis for gr. 100

### CHARACTERISTICS

**BROMAX PELLETT** is a ready-for-use rodenticide bait with at its base the anticoagulant active substance known as Bromadiolone, which is effective against House Mouse (*Mus musculus*), Grey Rat (*Rattus norvegicus*), and Black Rat (*Rattus rattus*) even after a single ingestion. Its formulation consists of pellets that are palatable for the rodents' species indicated. The product does not arouse neither alarm nor suspicion among the other members of the rodents' population.

**BROMAX PELLETT** contains a bitter substance aimed at preventing children from swallowing it accidentally.

**BROMAX PELLETT** can be used inside and around industrial buildings (including storehouses, warehouses, and ship holds), rural and civil buildings, houses, basements, garages, storerooms and relevant gardens or external areas.

### DOSES AND MODES OF USE

**BROMAX PELLETT** is a ready-for-use bait in the form of pellet to be used exclusively in tampering-proof duly marked bait containers, protected against atmospheric agents, the ingestion by non-target species and the dispersion into the environment.

The product is ready for use and must be employed in accordance with the doses below. Avoid touching the product with bare hands and use appropriate gloves. The rodenticide bait must be inserted in an appropriate container through a suitable calibrated dispenser (20 g), protected against atmospheric agents, the ingestion by non-target species the dispersion into the environment. Observe the infested area and put bait containers at burrows, along rodents' paths and in the places where they are mostly present. Should more containers be necessary, place them at a distance from one another of about 5-10 m and in any case at a distance not less than 5 metres.

#### Recommended doses are:

**House Mouse:** 2 pre-dosed internal packages (40 g) x 100 m<sup>2</sup>.

**Grey Rat:** 3-5 pre-dosed internal packages (60-100 g) x 100 m<sup>2</sup>.

**Black Rat:** 3-5 pre-dosed internal packages (60-100 g) x 100 m<sup>2</sup>.

Mark adequately the area involved in the treatment by indicating the risk of poisoning and the measures of first aid. Replace the baits in the containers every week if necessary. In case of permanent baiting, we recommend to re-visit the treated area at the latest every 4 weeks in order to avoid possible selection of resistant population. Read carefully product safety data sheet.
